Too long; didn't read? A super short summary

Change of Council Chair

Due to unforeseen circumstances, the Chair of ITU Council 2019, Dr Elsayed Elsayed Azzouz of Egypt, will not be able to attend the Council session. Instead, Mr Fabio Bigi of Italy was contacted by the ITU Secretariat on Friday, June 7, and agreed to fill in. Member States approved Mr Bigi as Chair by acclamation (clapping), with many Member States taking the time to thank him for his willingness to serve with so little notice.

Decisions about upcoming ITU conferences

Plenipotentiary Conference 2022:

- Romania, 26 September – 14 October 2022
(*Dates subject to change subject to further informal discussions at Council*)

World Telecommunication Standards Assembly 2020:

- Hyderabad, India, 16 to 27 November 2020

Improving key ITU processes

- Secretariat was asked to examine how to improve the working processes of Plenipotentiary conferences, including shortening the duration, and formalising a process of inter-regional preparation and coordination to get as much consensus achieved before the Plenipotentiary as possible.
- Member States agreed to refine the ethical principles for ITU election campaign activities, based on the *Ethical aspects of certain campaign activities prior to the 2018 Plenipotentiary Conference* guidelines adopted by ITU Council 2018.

Decisions made by ITU Council 2019 on Day 1

ITU Council members considered a number of reports from the ITU Secretariat as well as contributions from Member States, resulting in a number of actions on the documents. In summary, ITU Council 2019:¹

Decided:

- The venue for ITU Plenipotentiary Conference 2022 will be Bucharest, Romania

Also, adopted:

- The draft decision to hold the ITU Plenipotentiary Conference 2022 contained in Annex C of the same document, *Venue and dates of the 2022 Plenipotentiary Conference* (C19/55 Revision 1).

Note: Provisional dates of 26 September to 14 October 2022 to be further discussed amongst ITU Council Members and a final decision to be made before ITU Council 2019 ends.

- The venue for the World Telecommunication Standardization Assembly 2020 will be Hyderabad, India, 16 to 27 November 2020.
