Standing Committee for Administration and Management (ADM)

Approved:

Implementation of Resolution 131 (Rev. Dubai, 2018) - Measuring information and communication technologies to build an integrating and inclusive information society, as proposed by the Secretary-General, as long as the cost of the addition of four new staff positions to the ITU ICT Data and Statistics Division can be absorbed within the

current ITU budget or using identified savings and without causing any further financial implications for the ITU.

Also, the ADM Chair *noted*:

- Wide agreement that additional resources are needed; that the resources available currently be used efficiently, and that the BDT seek to utilize resources available in the Standardisation and Radiocommunication sectors.
- That a Council member had noted that the financial implications of Resolution 131 (Rev. Dubai, 2018) - Measuring information and communication technologies to build an integrating and inclusive information society, were not presented to Committee 6 during Plenipotentiary 2018.

In addition, the ITU Secretariat noted that the proposed action in a related contribution, *Proposal for the report on the progress on the implementation of Resolution 131 (rev. Dubai, 2018)*, was covered in the Secretariat's contribution (C19/10), and suggested no further action on the document.
