### Significant development

 Discussions on the ITU headquarters rebuilding project dominated the day, with the possibility raised of deferring starting the rebuilding project until the project budget can be confirmed as stabilised, with no additional costs to be factored in.

## Plenary

There was no plenary on Day 5.

### Standing Committee for Administration and Management (ADM)<sup>1</sup>

Approved:

 Secretary-General's recommendations for entities requesting exemption from Sector member fees as ITU Sector membership as listed in *Request for Exemption from any financial contribution to defraying expenses relating to participation in the work of ITU* <u>https://www.itu.int/md/S19-CL-C-0039/en</u>

The Secretary-General recommended four entities receive exemption from Sector member fees - including International Corporation for Assigned Names and Numbers (ICANN) and the Commonwealth Telecommunication Organization (CTO) – and recommended another three requests for exemption not be accepted, due to not meeting the established criteria for exemptions.

 Revision of Council Decision 482 as contained in Annex 2 of Part 1, "Recommendations on possible revision to Decision 482, Concerning complex/large non-GSO satellite filings", of Progress report recommending possible revision to Decision 482 concerning complex/large non-GSO satellite filings and exceptionally complex GSO satellite filings (C19/36 Revision 1). https://www.itu.int/md/S19-CL-C-0036/en

Also, recommends ITU Council 2022 to review:

- Decision 482, on the basis of statistics to be provided by the Radiocommunications Bureau, taking into account the items listed in Section 2 of Cost Recovery for the processing of Non-GSO Satellite Network Filings: Views on Procedure B and Proposal to Establish A Working Group to Consider Modification of the Methodology for Calculation of Units for Non-GSO systems.

Also, recommends to ITU Council:

- That regarding Procedure C, the cost associated with the software updates related to APFD examinations be discussed, based on the procedures described in section 7.1 of Part 1 of C19/36 Revision 1.
- To instruct the director of the radiocommunications Bureau to:
  - Include the information regarding potential regulatory solutions contained in Part 2, "Recommendations on possible revision to decision 482, Concerning

exceptionally complex GSO satellite filings" of Document, C19/36 Revision 1, in his report to World Radiocommunication Conference 2019.

- To endorse:
  - The instructions of the Radio Regulations Board to the Radio Regulations Bureau to contact the notifying administration of those networks drawing their attention to the consequences of processing of such networks: staff resource absorption and complications which could have a negative impact for subsequent submissions.

In addition, informal discussions on updating the Terms of Reference for the Council Expert Group on Resolution 482 are currently taking place and will be reported back to the next meeting of the ADM Committee.

 The Chair of ADM requested that informal consultations be conducted on the proposed revision of Council Resolution 925, Financial conditions for the participation of the United Nations, the Specialized Agencies and other International Organizations in the conferences and meetings of the ITU. Informal gathering of the group organized for the morning coffee break on 14 June. Proposal author to represent proposal to Standing Committee for Administration and Management (ADM) following conclusion of consultations.

 The Chair of ADM requested an informal drafting group on proposed revision of Council Decision 563, "Council Working Group on Financial and Human Resources (CWG-FHR)". No formal meeting time was specified.

 Following extensive discussions by Council members about the costs of the Union's headquarters premises project, the Chair of ADM requested informal consultations on the topic based on highly detailed information to be presented to interested parties and for discussions to resume during ADM on 18 June.

To summarise:

- Some Council members are concerned about the increase in projected expenses for building project, while other members are satisfied that pledged sponsorships for various rooms and facilities in the new building will cover the increased costs.
- Some members have suggested deferring starting the rebuilding project until finances and project details can be bedded down, with little to no possibilities of additional cost increases being added, meaning there is a **possibility of the building project being delayed**.
- It was noted that deferring, or possibly even cancelling, the rebuilding project at this time could lead to additional costs for ITU.

In addition, the Chair of the informal consultations was returning to capital over the weekend, meaning the Chair of Council 2019 will need to appoint a new Chair for the informal consultations.
- At its third meeting, the Working Group on ITRs completed work on the Terms of Reference for the Expert Group on International Telecommunication Regulations (EG-ITRs), as well as a revised draft Council Resolution 1379. The completed draft (DL/3 https://www.nissaba.net

Revision 4 - available only to TIES account holders) will be presented to Plenary for adoption.

The recommendations contained in Implementing the new PP-18 resolution on SME participation in ITU, including the recommendation for a maximum annual revenue level of CHF 15 million to fulfil the instruction in resolves 3 of the new resolution on SMEs, were initially approved by ADM, but following the lunch break, a Council member requested that the decision, and accompanying document, be reopened for discussion. This is likely to happen 18 June.
